ENTRIES - Entries must be post-marked by the closing date, and will be accepted in postmark date order **up to scheduling limit of show**, after which a waiting list will be kept. The organizer reserves the right to combine/cancel classes. **Negative coggins is required by State Law and each rider is responsible for having it available upon request, no need to mail a copy.**

CLASS FEES - **\$16 per class.** Classes will be held in order listed.
Office fee: \$10.00 per horse/rider combination.

REFUNDS – Only if cancelled prior to closing date - less \$10 office fee.
ABSOLUTELY, NO REFUNDS AFTER CLOSING DATE.

CLASSES 14 to 18 Horse/rider combinations may enter more than one test per class. Please specify test(s) on entry form. Classes may be divided or grouped depending on the number of entries. Western Dressage divisions will use USEF Western Dressage tests:
(<https://www.usef.org/IFrames/breedsdisciplines/discipline/allWesternDressage/WesternDressageTests.aspx>). Working Equitation will use 5-6 obstacles, test will be posted at www.rojasranch.com/events.

MUSICAL FREESTYLES – Sound system provided. Riders must provide an MP3 file on a thumb drive or smartphone. The music must be given to show secretary at least 15 min before freestyle is scheduled.

JUNIOR RIDER - Riders under 18 years of as of January 1st, 2017.

TIMES - Available by phone at 615-746-4308 on Thursday, October 26th between 5 & 8 p.m. Times posted on Facebook and the Rojas Ranch Website also: www.rojasranch.com/events on same day. Riding times will be also e-mailed to competitors on the same day if a **legible email address** is on entry form.

ARENAS - All tests will be ridden in a **20m x 56m** outdoor arena blue stone footing. Warm up on indoor arena or grass field. **No longeing allowed in indoor arena.** May longe in field behind the arena.

DRESS/ATTIRE –A helmet and heeled boots **MUST** be worn when mounted at any time. Costume or Standard show attire, coats are encouraged, not required.

DIRECTIONS – From I-24 Exit 24, (Springfield-Ashland City) go towards **Springfield** on Hwy 49, in about 1.7 miles there is a street on the right called **Ewell Elliot**, and on the left called **YORK Rd**. Turn left into **YORK Rd** and go just about 1/4 mile and the first street on the right is **HENRY GOWER RD**. Then turn Right into Henry Gower Rd and go about 2 miles to a big blue barn on the right side and a white fence. Driveway is at the end of the fence **#2571**. Name **ROJAS** is on the mail box.
